

STATUT UNIVERSITI PERTANIAN MALAYSIA (PEMBAHAGIAN UNIVERSITI
KEPADAA FAKULTI, YAYASAN DAN PUSAT) (PINDAAN) 1979

UNIVERSITI PERTANIAN MALAYSIA (DIVISION OF THE UNIVERSITY INTO
FACULTIES, INSTITUTIONS AND CENTRES) (AMENDMENT) STATUTE 1979

IN exercise of the powers conferred by section 26 of the Constitution of the University Agriculture Malaysia, the Chancellor of the Universiti Pertanian Malaysia makes the following Statute:

Citation and
commencement.

1. This Statute may be cited as the **Universiti Pertanian Malaysia (Division of the University into Faculties, Institutions and Centres) (Amendment) Statute 1979** and shall be deemed to have come into force on the 1st May 1979.

2. Paragraph 3 of the Universiti Pertanian Malaysia (Division of the University into Faculties, Institutions and Centres) Statute 1978 is amended by:

(a) deleting the word "and" appearing immediately after the word "Studies;" in subparagraph (1) (vii);

(b) substituting the word ";" and" for the full stop appearing immediately after the word "Education" in subparagraph (1) (viii); and

(c) adding a new subparagraph (1) (ix) as follows—

"(ix) the Faculty of Fisheries and Marine Science."
