Suatu Kaedah-Kaedah bagi meminda Kaedah-Kaedah Universiti Putra Malaysia (Perkara Penyelidikan) 2012.

PADA menjalankan kuasa yang diberikan oleh seksyen 37(1) Perlembagaan Universiti Putra Malaysia, Lembaga Pengarah Universiti Putra Malaysia membuat Kaedah-Kaedah yang berikut:

Tajuk Ringkas, Pemakaian dan Permulaan Kuat kuasa

1. Kaedah-Kaedah ini bolehlah dinamakan Kaedah-Kaedah Universiti Putra Malaysia (Perkara Penyelidikan)(Pindaan) 2012 dan hendaklah mula berkuat kuasa pada 11 September 2012.

Pindaan Perkataan “Fakulti”

2. Kaedah-Kaedah Universiti Putra Malaysia (Perkara Penyelidikan) 2012, yang disebut dalam Kaedah-Kaedah ini sebagai “Kaedah Ibu”, dipinda dengan menggantikan perkataan “fakulti” dalam semua Kaedah-Kaedah dan nota bahu yang mempunyai perkataan itu dengan perkataan “guru”.

Pindaan Kaedah 4(4)(a)

3. Kaedah 4(4)(a) Kaedah Ibu dipinda dengan—

(a) memotong sub-Kaedah (v);

(b) menomborkan semula sub-Kaedah (vi) dan (vii) sebagai sub-Kaedah (v) dan (vi) masing-masingnya.

Pindaan Kaedah 6(3)(b)

4. Kaedah 6(3)(b) Kaedah Ibu dipinda dengan memasukkan selepas perkataan “mendapat kebenaran bertulis” dan sebelum perkataan “Universiti sebelum penyebaran itu dibuat”, perkataan “secara khusus atau am daripada”.

A Rules to amend Universiti Putra Malaysia (Research) Rules 2012.

IN exercise of the power conferred by Section 37(1) of the Constitution of Universiti Putra Malaysia, the Board of Directors of Universiti Putra Malaysia makes the following Rules:

Short titles, Application and date of commencement

1. These Rules may be cited as Universiti Putra Malaysia (Research) (Amendment) 2012 and shall be in force on 11 September 2012.

Amendment to the word “Faculty”

2. Universiti Putra Malaysia (Research) Rules 2012, which is referred to as the “Parent Rules” in these Rules, are amended by substituting the word “faculty” in all the rules and shoulder note which contained the word with the word “teachers”.

Amendment of Rule 4(4)(a)

3. Rule 4(4)(a) of the Parent Rules is amended by—
 - (a) deleting sub-Rule (v);
 - (b) renumbering sub-Rule (vi) and (vii) as sub-Rule (v) and (vi) respectively.

Amendment of Rule 6(3)(b)

4. Rule 6(3)(b) of the Parent Rules is amended by inserting after the word “have obtained a written consent” and before the word “from the University before the dissemination is made”, the word “either specifically or generally”.
