**KAEDAH-KAEDAH UNIVERSITI PERTANIAN MALAYSIA
(TATATERTIB PELAJAR-PELAJAR) (PINDAAN) 1996**

Universiti dan Kolej Universiti 1971, Majlis Universiti bagi Universiti
Pertanian Malaysia membuat kaedah-kaedah yang berikut:

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Nama.

2. Kaedah-Kaedah Universiti Pertanian Malaysia (Tataterrib Pelajar-
Pelajar) 1975, yang disebut "Kaedah-Kaedah ibu" dalam Kaedah-
Kaedah ini, adalah dipinda dalam kaedah 2—
Pindaan
kaedah 2.

(a) dengan memasukkan selepas takrif "meletak kereta" takrif
yang berikut:

‘ “menipu” termasuklah meniru;’;

(b) dengan memasukkan selepas takrif "pegawai" takrif yang
berikut:

‘ “pelajar” termasuklah mana-mana pelajar ijazah
lanjutan, pelajar separuh masa, pelajar rancangan pengajian
luar kampus, pelajar diploma, pelajar matrikulasi, pelajar
tanpa ijazah bagi Universiti dan mereka yang mengikuti
kursus secara penuh masa atau secara separuh masa di
Universiti;’ dan

(c) dengan memasukkan selepas takrif "Pengetua" takrif yang
berikut:

‘ “peperiksaan” termasuklah apa-apa cara atau kaedah
penilaian untuk memberi markah atau gred bagi sesuatu
kursus atau sebahagian daripadanya;’.

3. Kaedah 3 Kaedah-Kaedah ibu adalah dipinda dengan menggantikan noktah di hujung perenggan (*k*) dengan perkataan “; atau ” dan memasukkan selepasnya perenggan yang berikut:

4. Kaedah-Kaedah ibu adalah dipinda dengan menggantikan kaedah 16 dengan kaedah yang berikut:

“Meminum,
dsb. minuman
keras dan
berkelakuan
tidak senonoh.

16. (1) Tiada seorang pelajar pun boleh meminum atau ada dalam milikannya, di bawah jagaannya atau kawalannya apa-apa minuman keras di dalam Kampus.

(2) Mana-mana pelajar yang berkelakuan tidak senonoh di dalam Kampus kerana pengaruh minuman keras adalah melakukan suatu kesalahan tatatertib.”.

5. Kaedah-Kaedah ibu adalah dipinda dengan memasukkan selepas kaedah 22 kaedah yang berikut:

“Kuasa Naib
Canselor untuk
mengeluarkan
arahan
mengenai
cara pelajar
berpakaian.

22A. Naib Canselor boleh mengeluarkan apa-apa arahan yang difikirkan perlu, secara bertulis, berhubungan dengan cara berpakaian bagi pelajar di dalam Kampus.”.

UNIVERSITIES AND UNIVERSITY COLLEGES ACT 1971

UNIVERSITI PERTANIAN MALAYSIA (DISCIPLINE OF STUDENTS) (AMENDMENT) RULES 1996

Act 30.

In exercise of the powers conferred by section 16c of the Universities and University Colleges Act 1971, the University Council of the Universiti Pertanian Malaysia makes the following rules:

Citation.

1. These rules may be cited as the **Universiti Pertanian Malaysia (Discipline of Students) (Amendment) Rules 1996**.

2. The Universiti Pertanian Malaysia (Discipline of Students) Rules 1975, which in this Rules is referred to as "the principal Rules", is amended in rule 2—

(a) by inserting after the definition of "authorised person" the following definition:

' "cheating" includes copying;';

(b) by inserting after the definition of "drug" the following definition:

' "examinations" includes any manner or method of assessment which results in a mark or a grade for a specific course or part thereof;'; and

(c) by inserting after the definition of "staff" the following definition:

' "student" includes any postgraduate student, part-time student, student under the off-campus programme, diploma student, matriculation student, non-graduating student of the University and those doing full-time or part-time courses at the University;'.

3. Rule 3 of the principal Rules is amended by substituting for the full stop at the end of paragraph (k) the words "; or" and inserting thereafter the following paragraph:

"(l) cheat or attempt to cheat or conduct himself in a manner which can be construed as cheating or attempting to cheat in an examination, while the examination is being conducted.".

4. The principal Rules is amended by substituting for rule 16 the following rule:

Amendment
of rule 16.

"Consuming,
etc. liquor and
behaving in
a disorderly
manner.

16. (1) No student shall, within the Campus, consume or have in his possession, custody or control any liquor.

(2) Any student who behaves in a disorderly manner under the influence of liquor, within the Campus, shall be guilty of a disciplinary offence.".

5. The principal Rules is amended by inserting after rule 22 the following rule:

New rule
22A.

"Power of
Vice-Chancellor
to issue
directions on
manner of
dressing of
students.

22A. The Vice-Chancellor may issue such directions, in writing, as he deems necessary in relation to the manner of dressing of students in the Campus.".
