CONSTITUTION OF UNIVERSITI PUTRA MALAYSIA

UNIVERSITI PUTRA MALAYSIA (ELECTION OF STUDENTS' UNION OF THE UNIVERSITY FOR THE STUDENTS' REPRESENTATIVE (COUNCIL) (AMENDMENT) 2021

Regulations to amend Universiti Putra Malaysia (Election of the Students' Union of the University for the Students Representation Council) Regulation 2019.

IN EXERSICE of the power conferred under subsection 57(2) of the Constitution of the Universiti Putra Malaysia [P.U.(A) 448/2010], the Board makes the following regulations:

PART I

PRELIMINARY

Name and Commencement

1. This Regulations may be cited as Universiti Putra Malaysia (Election of the Students' Union of the University for the Students' Representative Council) (Amendment) Regulation 2021 and shall come into force on 1st March 2021.

Interpretation

2. In these Regulations unless the context otherwise requires:

"Parent Regulations" means Universiti Putra Malaysia (Election of Students' Union of the University for the Students' Representative Council) Regulations 2019.

PART II

AMENDMENT TO THE PARENT REGULATIONS

Amendment to the Parent Regulations

- 3. The Parent Regulations are amended as follows—
 - (a) by inserting after the interpretation of the word "Assistant Head of Voting Centre" in Regulation 2 of Parent Regulations, the following paragraph:

"Electronic Device" mean any device which may access the e-ballot system provided in the prescribed website or portal as determined by the SRC Election Main Committee such as mobile phone or laptop,";

(b) by substituting the interpretation of "e-voting" in Regulation 2 of Parent Regulations, as follows:

"e-voting" means SRC Election system conducted by electronic means which may be accessed by voting computer or electronic device through prescribed website or portal as determined by the SRC Election Main Committee":

- (c) by inserting after the interpretation of the word "Existing SRC" in the Regulation 2 of the Parent Regulations, the following paragraph:
- "Official University Notice Board" means official notice board within the University or on official website or social media of the University.";
- (d) by substituting the interpretation of "Votes Centre" in the Regulation 2 of the Parent Regulations, as follows:
- "Voting Centre" means any area, including any prescribed website or portal as determined by the SRC Election Main Committee for voting.";
- (e) by substituting the whole subregulation 29(3) of the Parent Regulations, as follow:
 - "29(3) A member of the University Students' Union wishing to vote shall:
 - (a) submit either physically or virtually his valid student card; or
- (b) use username and password registered with the University which indicates the status of member of the Union as a registered University student before he is allowed to vote.";
- (f) by substituting the whole subregulation 32(1)(a) of the Parent Regulations, as follows:
- "(a) running any form of campaign on the day of voting either through printed or verbal and online social media applications.";
- (g) by substituting the whole subregulation 34(2) of the Parent Regulations, as follows:

- "(2) Voting by e-voting may be carried out using voting computer or electronic device.";
- (h) by inserting after the word "entering" and before the word "the voting centre" the word "or accessing".;
- (i) By substituting the shoulder note of Regulation 35 of the Parent Regulations to "Server Computer, Voting Computer and Electronic Device."
- (j) by inserting after subparagraph 35(2)(b), the following subparagraph:
- "(c) server computer and voting computer at the Voting Centre may be accessed online by the member of the University Students' Union.";
- (k) by substituting the whole of subregulation 35(3) of the Parent Regulations as follows:

"SRC Election Audit Committee shall certify:

- (a) the validity of server computer and voting computer at the Voting Centre; and
- (b) the accessibility of the e-ballot online system by the member of the University Students' Union through electronic device for the voting purpose;

after the Committee is satisfied that the provisions in the subparagraph 35(2)(a) and (b) have been complied with."

(*l*) by substituting the whole of subregulation 35(5) of the Parent Regulations, as follows:

"(5) The Head of Voting Centre shall switch off the server computer and voting computer and ensure that the prescribed website or portal as determined by SRC Election Main Committee are not accessible online by any electronic devices at the end of voting period."
