1. These Regulations may be cited as the Registration of Engineers (Institutions) Regulations 1987.

2. The Board of Engineers in the Registration of Engineers Regulations 1967 is amended by adding the following:

"Institution Pertanian Malaysia . . . (1) and (2) and (3)";

AKTA UNIVERSITI DAN KOLEJ UNIVERSITI 1971
 PERINTAH UNIVERSITI PERTANIAN MALAYSIA (KAMPUS)
 (No. 2) 1987

PADA menjalankan kuasa-kuasa yang diberi kepadanya oleh seksyen 12 Akta Universiti dan Kolej Universiti 1971, Yang di-Pertuan Agong membuat perintah yang berikut:

Akta 30.

Nama dan mula berkuat-kuasa.

Penubuhan Kampus.

1. Perintah ini bolehlah dinamakan **Perintah Universiti Pertanian Malaysia (Kampus) (No. 2) 1987** dan hendaklah disifatkan telah mula berkuatkuasa pada 1hb Jun 1987.
2. Apabila Perintah ini mula berkuatkuasa—
 - (a) maka adalah dengan ini ditubuhkan suatu kampus bagi Universiti Pertanian Malaysia;
 - (b) nama dan gelaran Kampus itu ialah "Kampus—Universiti Pertanian Malaysia";
 - (c) Kampus itu adalah, selain daripada Kampus di mana Universiti itu didirikan, terletak di Lot No. 11, 12, 14 dan 15 dalam Blok No. 26 di Daerah Tanah Kemena, Bahagian Bintulu, dalam Negeri Sarawak; dan

- (d) Institut Sains Asasi, Institut Sains Gunaan, dan Institut Sains Sosial dan Pengurusan hendaklah terletak di Kampus itu.

UNIVERSITIES AND UNIVERSITY COLLEGES ACT 1971

UNIVERSITI PERTANIAN MALAYSIA (CAMPUS)
(No. 2) ORDER 1987

In exercise of the powers conferred by section 12 of the Universities and University Colleges Act 1971, the Yang di-Pertuan Agong makes the following order: Act 30.

1. This Order may be cited as the **Universiti Pertanian Malaysia (Campus) (No. 2) Order 1987** and shall be deemed to have come into force on the 1st day of June 1987. Citation and commencement.
2. Upon the coming into force of this Order— Establishment of Campus.
 - (a) there is established a Campus of the Universiti Pertanian Malaysia;
 - (b) the name and style of the Campus shall be "Universiti Pertanian Malaysia—Campus";
 - (c) the Campus shall, in addition to the Campus at the seat of the University, be located at Lot No. 11, 12, 14 and 15 in Block No. 26 in the Kemena Land District in the Bintulu Division in the State of Sarawak; and
 - (d) the Institute of Basic Sciences, the Institute of Applied Sciences, and the Institute of Social and Management Sciences shall be located in the Campus.
