

P.U. (B) 507.**AKTA UNIVERSITI DAN KOLEJ UNIVERSITI 1971****PERLEMBAGAAN UNIVERSITI PERTANIAN MALAYSIA****AKTA UNIVERSITI PERTANIAN MALAYSIA (ACARA KONVOKESYEN) 1977**

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 28 Perlembagaan Universiti Pertanian Malaysia, Majlis Universiti Pertanian Malaysia selepas berunding dengan Canselor mengikut kehendak seksyen 44 Perlembagaan Universiti Pertanian Malaysia membuat Akta yang berikut:

1. Akta ini bolehlah dinamakan **Akta Universiti Pertanian Malaysia Nama. (Acara Konvokesyen) 1977.**

2. (1) Dalam Akta ini, melainkan jika kandungan ayatnya meng-

hendaki makna yang lain—

“Fakulti” adalah termasuk sesuatu Yayasan atau Pusat yang bukan sebahagian daripada sesuatu Fakulti.

(2) Akta ini hendaklah dipakai dengan apa-apa ubahsuaian yang perlu apabila sesuatu Konvokesyen dipengerusikan oleh seorang Pro Canselor atau oleh Naib Canselor.

3. Suatu Konvokesyen bagi pengurniaan ijazah-ijazah dan diploma-
diploma hendaklah diadakan pada tiap-tiap tahun, atau seberapa kerap
yang diarahkan oleh Canselor, pada tarikh dan tempat yang diluluskan
oleh Canselor.

4. Ijazah-ijazah dan diploma-diploma Universiti hendaklah biasanya dikurniakan hanya kepada orang-orang yang hadir disesuatu Konvokesyen dengan syarat bahawa Senat boleh, dalam keadaan luar biasa, memutuskan supaya sesuatu ijazah atau diploma dikurniakan tanpa hadir.

5. (1) Sesuatu Konvokesyen hendaklah dipengerusikan oleh Canselor atau, jika Canselor tidak hadir, oleh seorang Pro Canselor yang diberi kuasa bagi maksud ini oleh Canselor.

(2) Jika Canselor dan Pro Canselor yang diberi kuasa bagi maksud ini oleh Canselor tidak hadir pada sesuatu Konvokesyen, Konvokesyen itu hendaklah dipengerusikan oleh Naib Canselor.

- Pengisytiharan.
6. Pengisytiharan membuka dan menutup Konvokesyen hendaklah dilakukan oleh Canselor.
- Tertib pengurniaan ijazah dan diploma.
7. Ijazah-ijazah dan diploma-diploma hendaklah dikurniakan menurut tertib yang berikut—
Ijazah-ijazah Kehormat menurut tertib yang ditetapkan oleh Senat;
Ijazah-ijazah Doktor selain daripada Doktor Falsafah menurut tertib Fakulti;
Ijazah Doktor Falsafah menurut tertib Fakulti;
Ijazah-ijazah Master menurut tertib Fakulti;
Ijazah-ijazah Bacelor menurut tertib Fakulti;
Diploma-diploma menurut tertib Fakulti.
- Hadiyah-hadiyah.
8. Selepas semua ijazah dan diploma telah dikurniakan, Naib Canselor hendaklah membacakan senarai hadiah-hadiah yang diberi berdasarkan kepada keputusan peperiksaan, dan Canselor hendaklah menyampaikan sijil-sijil yang berkaitan, jika ada.
- Ucapan.
9. Ucapan Konvokesyen, jika ada, hendaklah disampaikan selepas semua ijazah dan diploma dikurniakan dan sijil-sijil disampaikan.
- Doa Selamat.
10. Doa Selamat Konvokesyen hendaklah dibacakan sebelum pengisytiharan menutup Konvokesyen oleh Canselor.

UNIVERSITY AND UNIVERSITY COLLEGES ACT 1971

UNIVERSITY PERTANIAN MALAYSIA CONSTITUTION

**UNIVERSITY PERTANIAN MALAYSIA (CONVOCATION PROCEDURE)
ACT 1977**

P.U. (A)
409/76.

IN exercise of the powers conferred by section 28 of the Constitution of the University Pertanian Malaysia, the Council of the University Pertanian Malaysia after consultation with the Chancellor in accordance with the requirements or section 44 of the Constitution of the University Pertanian Malaysia makes the following Act:

- Citation.
1. This Act may be cited as the **University Pertanian Malaysia (Convocation Procedure) Act 1977**.
- Interpretation.
2. (1) In this Act unless the context otherwise requires—
“Faculty” includes an Institution or Centre which is not a part of any Faculty.
(2) This Act shall apply with such modification as may be necessary depending on whether a Pro-Chancellor or Vice-Chancellor presides over a Convocation.
- Convocation.
3. A Convocation for the conferment of degrees and diplomas shall be held annually or as often as the Chancellor may direct on such date and at such place as may be approved by the Chancellor.
- Conferment of degrees and diplomas to persons present.
4. Degrees and diplomas of the University ordinarily shall be conferred to persons who are present at a Convocation, on condition that the Senate may, in exceptional cases, decide that a degree or diploma be conferred in a person's absence.

5. (1) The Chancellor shall preside over the Convocation or, if the Convocation Chairman. Chancellor is not present, by a Pro-Chancellor who is authorised for this purpose by the Chancellor.

(2) If the Chancellor or the Pro-Chancellor who is authorised for this purpose by the Chancellor is not present at a Convocation, then the Vice-Chancellor shall preside over the Convocation.

6. The declaration to open and close the Convocation shall be Declaration. performed by the Chancellor.

7. Degrees and diplomas shall be conferred according to the following Order of conferment of degrees and diplomas. order—

Honorary degrees according to the order determined by the Senate;

Doctorate degrees other than Doctor of Philosophy according to the Faculty order;

Doctor of Philosophy degrees according to the Faculty order;

Masters degrees according to the Faculty order;

Bachelor degrees according to the Faculty order;

Diplomas according to the Faculty order.

8. After the conferment of all degrees and diplomas, the Vice- Prizes. Chancellor shall read the list of prizes which are awarded based on the examination results, and the Chancellor shall award the certificates, if there are any.

9. The Convocation speech, if there is, shall be delivered after all the Speech. degrees and diplomas have been conferred and the certificates awarded.

10. The doa selamat of the Convocation shall be read before the Doa Selamat. declaration of the closing of the Convocation by the Chancellor.
