#### **KAEDAH-KAEDAH UNIVERSITI PUTRA MALAYSIA (TEKNOLOGI MAKLUMAT DAN KOMUNIKASI) (PINDAAN) 2016**

Suatu Kaedah-Kaedah bagi meminda Kaedah-Kaedah Universiti Putra Malaysia (Teknologi Maklumat Dan Komunikasi) 2016.

PADA menjalankan kuasa yang diberikan oleh seksyen 37(1) Perlembagaan Universiti Putra Malaysia, Lembaga Pengarah Universiti Putra Malaysia membuat Kaedah-Kaedah yang berikut:

#### **Tajuk Ringkas, Pemakaian dan Permulaan Kuat kuasa**

1. Kaedah-Kaedah ini bolehlah dinamakan Kaedah-Kaedah Universiti Putra Malaysia (Teknologi Maklumat Dan Komunikasi) (Pindaan) 2016 dan hendaklah mula berkuat kuasa pada 1 Oktober 2015.

#### **Tafsiran**

2. Dalam Kaedah-Kaedah ini, melainkan konteksnya menghendaki makna yang lain:-

“Kaedah-Kaedah Ibu” ertinya Kaedah-Kaedah Universiti Putra Malaysia (Teknologi Maklumat dan Komunikasi) 2014.

### **Pindaan subkaedah 5**

3. Subkaedah 5(1)(a) dipinda dengan menggantikan perenggan (a) Kaedah-Kaedah Ibu dengan perenggan berikut:-

- (a) mana-mana Timbalan Naib Canselor Universiti, atau mana-mana pegawai yang disebut dalam seksyen 14 Perlembagaan Universiti, atau mana-mana pekerja lain, yang dilantik oleh Naib Canselor, yang hendaklah menjadi Pengerusi.

**UNIVERSITI PUTRA MALAYSIA (INFORMATION AND  
COMMUNICATION TECHNOLOGY) (AMENDMENT) RULES 2016**

A Rules to amend Universiti Putra Malaysia (Information And Communication Technology) Rules 2016.

IN exercise of the power conferred by section 37(1) of the Constitution of Universiti Putra Malaysia, the Board of Directors makes the following Rules:

**Short Titles, Application and Date of Commencement**

1. These Rules may be cited as Universiti Putra Malaysia (Information and Communication Technology) (Amendment) 2016 and shall come into force on 1<sup>st</sup> October 2015.

**Interpretation**

2. In these Rules, unless the context otherwise required:-

“Parent Rules” means Universiti Putra Malaysia (Information and Communication Technology) Rules 2014.

**Amendment to subrule 5**

3. Subrule 5(1)(a) is amended by substituting the paragraph (a) of the Parents Rules with the following paragraph:-

- (a) a Deputy Vice Chancellor of the University, or an officer mentioned in section 14 of the University Constitution, or an employee of the University, appointed by the Vice Chancellor, who shall be the Chairman.
