

5. (1) The Chancellor shall preside over the Convocation or, if the Chancellor is not present, by a Pro-Chancellor who is authorised for this purpose by the Chancellor. Convocation Chairman.
- (2) If the Chancellor or the Pro-Chancellor who is authorised for this purpose by the Chancellor is not present at a Convocation, then the Vice-Chancellor shall preside over the Convocation.
6. The declaration to open and close the Convocation shall be performed by the Chancellor. Declaration.
7. Degrees and diplomas shall be conferred according to the following order— Order of conferment of degrees and diplomas.
- Honorary degrees according to the order determined by the Senate;
- Doctorate degrees other than Doctor of Philosophy according to the Faculty order;
- Doctor of Philosophy degrees according to the Faculty order;
- Masters degrees according to the Faculty order;
- Bachelor degrees according to the Faculty order;
- Diplomas according to the Faculty order.
8. After the conferment of all degrees and diplomas, the Vice-Chancellor shall read the list of prizes which are awarded based on the examination results, and the Chancellor shall award the certificates, if there are any. Prizes.
9. The Convocation speech, if there is, shall be delivered after all the degrees and diplomas have been conferred and the certificates awarded. Speech.
10. The doa selamat of the Convocation shall be read before the declaration of the closing of the Convocation by the Chancellor. Doa Selamat.

**AKTA UNIVERSITI DAN KOLEJ UNIVERSITI 1971  
PERLEMBAGAAN UNIVERSITI PERTANIAN MALAYSIA**

**AKTA UNIVERSITI PERTANIAN MALAYSIA (PESEKUTU AKADEMIK) 1977**

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 28 Perlembagaan Universiti Pertanian Malaysia, Majlis Universiti Pertanian Malaysia membuat Akta yang berikut mengikut peruntukan seksyen 28 tersebut: P.U. (A)  
409/76.

1. Akta ini boleh dinamakan **Akta Universiti Pertanian Malaysia (Pesekutu Akademik) 1977.** Nama.
2. Jika disyorkan oleh Senat, Majlis boleh melantik orang perseorangan, firma, yaysan, jabatan Kerajaan atau pertubuhan lain sebagai Pesekutu Akademik dalam sesuatu Fakulti, Pusat atau Yayasan bagi maksud mengiktiraf sumbangan mereka dalam bidang pengajaran atau penyelidikan Universiti. Perlantikan Pesekutu Akademik.
3. Perlantikan seseorang sebagai Pesekutu Akademik tidak boleh ditafsirkan sebagai memberinya hak untuk menjadi ahli sesuatu pihak berkuasa Universiti atau sesuatu badan lain di Universiti atau sebagai memberinya kuasa bagi menjalankan apa-apa tugas kerja atau pentadbiran. Perlantikan tidak memberi hak.

- Tempoh perlantikan. 4. Tertakluk kepada perenggan 5 Akta ini, tiap-tiap Pesekutu Akademik hendaklah dilantik bagi tempoh tidak lebih daripada tiga tahun :  
Dengan syarat bahawa seseorang atau sesuatu Pesekutu Akademik yang telah tamat tempoh lantikannya boleh dilantik semula.
- Lantikan boleh ditarik balik. 5. Lantikan sebagai Pesekutu Akademik boleh pada bila-bila masa ditarik balik oleh Majlis jika disyorkan demikian oleh Senat.
- Peraturan mengenai perlantikan dan lain-lain lagi. 6. Tertakluk kepada Akta ini, Majlis boleh membuat Peraturan-peraturan bagi menetapkan cara-cara dan syarat-syarat perlantikan Pesekutu-pesekutu Akademik, hak-hak dan tanggungjawab-tanggungjawab mereka, dan lain-lain perkara yang bersangkutan dengannya.

UNIVERSITY AND UNIVERSITY COLLEGES ACT 1971  
UNIVERSITY PERTANIAN MALAYSIA CONSTITUTION  
UNIVERSITY PERTANIAN MALAYSIA (ACADEMIC ASSOCIATE) ACT 1977

P.U. (A)  
409/76.

In exercise of the powers conferred by section 28 of the Constitution of the University Pertanian Malaysia, the Council of the University Pertanian Malaysia in accordance with the provisions of the said section 28 makes the following Act:

- Citation. 1. This Act may be cited as the **University Pertanian Malaysia (Academic Associate) Act 1977.**
- Appointment of Academic Associate. 2. If recommended by the Senate, the Council may appoint individuals, firms, institutions, Government departments or other organisations as Academic Associate in any Faculty, Centre or Institution in recognition of their contributions to the University in the fields of instruction or research.
- Appointment does not confer rights. 3. The appointment of a person as an Academic Associate shall not be interpreted as conferring him with the right to be a member of any University authority or any other body in the University or as conferring him with the power to carry out any executive or administrative functions.
- Period of appointment. 4. Subject to paragraph 5 of this Act, every Academic Associate shall be appointed for a period not exceeding three years:  
Provided that a person or an Academic Associate who has completed his period of appointment shall be eligible for reappointment.
- Appointment may be withdrawn. 5. Appointment as an Academic Associate may be withdrawn at any time by the Council if it is so recommended by the Senate.
- Regulations concerning conditions of appointment and others. 6. Subject to this Act, the Council may make Regulations to determine the methods and conditions of appointment of Academic Associate, their rights and responsibilities, and other related matters.
